



## 2018 Card Making Competition

A judged competition in conjunction with the 2018 Scrapbook & Papercraft Expo,  
June 7 – 10, 2018, Brisbane Convention & Exhibition Centre  
Sponsored by Expertise Events Pty Ltd

### The Competition:

Residents of Australia and New Zealand are invited to enter a competition to create a card, up to a maximum size of A5 when folded. The theme is Congratulations! and the card may be for any occasion. Entries are to be sent by post and a selection of finalists will be displayed at the expo and judged by visitors in a Viewers' Choice competition.

Entrants must elect to enter one of four categories:

1. Card with stamped design
2. Card with cut-out design, may be hand cut or machine cut
3. Card featuring 3D design or paper tole
4. Card featuring mixed media

Each category winner receives \$100, total prize pool of \$400.

### SUMMARY: COMPETITION DEADLINES

- Before May 25, 2018

Fill in the entry form online and post your actual entry to arrive before May 25, with a self-addressed and stamped envelope (large enough to return the entry to you) to: **Card Making Competition, Expertise Events, PO Box 6053, Frenchs Forest, NSW 2086**

- June 7 to 10, 2018

Finalist entries will be exhibited and judged by Viewers' Choice competition at the Expo.

- June 10, 2018

Voting will close at 12noon and winners will be announced at 3pm then notified by phone and email the following week.

- June 20 to 24, 2018

Entries will be displayed at Sydney Craft & Quilt Fair

- July, 2018

Entries will be returned to owner if a self-addressed stamped envelope has been provided.

### RULES

1. Entries will be juried by a panel of judges; then finalists will be judged by Viewers' Choice at the Scrapbook & Papercraft Expo.
2. Any individual or groups may enter, as long as all those who contribute to the entry are nominated on the entry form. A limit of four entries per person or group applies.

3. This competition is open to entrants from Australia and New Zealand only.
4. Entries must have been completed after January 2018, not prior to this.
5. All entries must be received no later than May 25, 2018.
6. Employees and family members of Expertise Events are not eligible to enter.
7. Entries must be labelled clearly with the entrant's name, address, telephone number and email, and the name of the work on the back.
8. Entries must have adhesive Velcro dots attached (HOOK side only) in each corner to facilitate display.
9. The entrant/s stated on the Entry Form must be the maker/s of the entry.
10. Entries must be a maximum size of A5 (148mm X 210mm) when folded.
11. Entries must be available for display at the Brisbane Scrapbook & Papercraft Expo (June 7 – 10, 2018) and Sydney Craft & Quilt Fair (June 20 - 24, 2018)
12. Entries cannot be collected in person at the event but will be returned by post to the owner after the event if accompanied by a self addressed stamped envelope or satchel of suitable size.
13. Expertise Events will take all care but no responsibility for any damage to or theft of an entry that occurs while the entry is in the care of Expertise Events. If insurance of any kind is required, this is the responsibility of the entrant and will be at their cost.

## HOW TO ENTER

14. **ENTRY FORM AND ENTRY:** Complete the online entry form. Post your actual entry to arrive at Frenchs Forest in Sydney before May 25, 2018. Include a self-addressed stamped envelope or post-pack with enough stamps to cover the cost of return of the entry.
15. The judges' decision is final and no correspondence will be entered into. Upon seeing the final works, the competition sponsor reserves the right to decide which works will be included in the exhibition. The organisers reserve the right to refuse any work that is deemed unsuitable or offensive. The judges may reserve the right to withhold an award if the standard of work does not warrant the award, or award two equal winners to share the prize.
16. **Copyright & Moral Rights:** By entering the competition the entrant gives permission for Expertise Events Pty Ltd (Expertise Events) to photograph their artwork and agree and acknowledge that all copyright of the photographs that Expertise Events takes of an entrant's work both current and in the future is that of Expertise Events. The entrant further grants Expertise Events licence to produce, reproduce and publish an entrant's statement as it is submitted on the entry form in whole or part throughout the world, which may be used in articles, ads, promotions, catalogues, books, and other media for and about the Scrapbook & Papercraft Expo special exhibit Competition or for and about scrapbooking, papercraft and creativity in perpetuity from time to time. The entrant retains copyright in the artwork and the photographs which the entrant submits with their entry save and except that the entrant grants Expertise Events the right to reproduce the digital photographs forwarded with the entry form, in a format for the purposes of the internal judging process and/or publicity and promotion.
20. **Confirmation of receipt of finalist entries.** It will be up to the entrant to call Expertise Events on 02 9452 7575 or email [scrap@expertiseevents.com.au](mailto:scrap@expertiseevents.com.au) to inquire as to receipt of delivery. No liability will be accepted by Expertise Events for the failure of the postal system delivery.
21. **Notification of Selection.** After entries are received, a list of finalists will be placed on the event website. The judges' decision is final and no correspondence will be entered into regarding finalist selection.
22. **Awarding of prize monies.** Winners will be selected in a Viewers' Choice vote during the Brisbane Scrapbook & Papercraft Expo, June 7 – 10, 2018 from opening on June 7 to 12noon on June 10 when voting will close and will be announced at the event and notified by phone and email the following week. Winners must provide bank account details by July 1, 2018 so that the prize money will be credited into their account. In the event that a winner cannot be contacted or does not provide account details by the deadline, Expertise Events reserves the right to withhold prize money or move the next highest judged entry up in selection.
24. **Entry Returns.** Entries will be returned by post during the month of July, 2018. Entries CANNOT be collected at the Expo at which they appear.
25. This is a judged competition and chance plays no part.
